#### Описание объекта:

This magnificent property is situated on a 175,000 sqm plot in the middle of the nature reserve between Manacor and Colònia de Sant Pere, just 10 km from the sea. It consists of a large two-storey main house, another single-storey house (both with a pool), a tennis court and multi-sports court, stables, shelters, carports and other outdoor areas.

The main house has a total of 7 bedrooms, 6 bathrooms (5 of which are en-suite), a kitchen with outdoor kitchen, a large living/dining room with fireplace, a utility room, separate laundry room with shower and toilet chain, storage rooms as well as a carport and a covered lounge area by the pool. There is central heating throughout the house, and all bedrooms and the living room also have air conditioning. A large, heated saltwater pool, spacious terraces and various barbecue and baking areas invite you to spend a lot of time outdoors.

The somewhat smaller house consists of 3 bedrooms, 3 bathrooms (2 of which are en-suite), a kitchen, a living/dining room, a large covered terrace, a laundry room with shower and toilet. In the basement there is also a large utility room with shower and toilet and a garage. A private pool and barbecue area make Mallorcan finca life perfect here too.

The finca is located in a cul-de-sac with a very convenient and asphalted driveway from the main road. At the entrance gate there is a large tennis and multi-sports court with changing room, shower and toilet.

On the extensive grounds there are wild tortoises, a variety of olive and fig trees, various fruit trees and herb plants, there is enough space for a kitchen garden and the cultivation of fodder plants, and if interested, animals such as donkeys, sheep or goats can also be adopted.
