### Описание объекта:

This very well-maintained and spaciouly-designed finca is only 4 km away from the lovely village of Santanyi, with the most beautiful sandy beaches on the island nearby.

Built in 2014, the house has a living space of approx. 330 sqm and stands on a Mediterranean-style plot of 14.700 sqm.

The house is entered via an imposing entrance area with high ceilings, which accesses the upper floor with 3 bedrooms, each with en-suite bathroom. Located on the ground level is a further bedroom and bathroom, and the open living/dining area with high-quality kitchen.

An absolute eye-catcher is provided by a large wooden door leading to the newest part of the finca. In 2022 a luxurious spa zone was built here and includes a heated indoor pool and a steam-sauna assuring pleasant relaxation and atmosphere during the colder months of the year. Also in this extension is a further bedroom with bathroom en suite, and a room which would be ideal, for example, for use as a fitness room.

The exterior area and gardens are low-maintenance, and contain a 54 sqm pool, diverse terraces and south-facing relaxation areas.

This exceptional property is very centrally situated, not far from the most beautiful beaches and only 4 km. from the village of Santanyi. Thanks to the underfloor heating, the heated pool, and the surrounding infrastructure, the house would be perfect for year-round occupation.
