#### Описание объекта:

This lovely town-house is situated in the charming typical Mallorcan village of Búger. Although very quietly located it is also conveniently connected and is only a short distance from the Palma-Alcudia motorway. Diverse beaches and the island's capital of Palma can be reached in only 20 to 30 minutes, and the Tramuntana mountains are only a few minutes away.

The property has a living space of approx. 200 sqm, spread over 3 levels and distributed over 3 bedrooms, 2 of which have bathrooms en suite, a modern fitted kitchen, and a large living/dining area. The house was extensively modernised only a few years ago, whilst taking care to retain its traditional charm.

Further features include everything required for a comfortable stay including hot/cold air conditioning, a pool, a large, flat-screen TV, and speedy fibre-optic internet, making it ideal for use as a home office.

On the lowest level is the convenient, spacious garage and a large storage room with its own bathroom/WC.

The house also has a large terrace with pool and a small roof terrace, both of which are west-facing and provide enchanting views of the beautiful sunsets.

Búger is a traditional Mallorcan village and offers panoramic views over half of the island thanks to its prominent and raised location, and has a supermarket, a pharmacy, a bakery, two cafes and a restaurant.


